To be thorough, you should check with your local DMV office to make sure you are completing all the necessary requirements before you take the CT Driving Exam.

You should feel comfortable accelerating smoothly and gradually, passing through intersections safely, change lanes effective, coming to a complete stop at stop signs and traffic signals, parking and parallel parking, maintaining the speed limit, staying in the correct lane and more. Remember during your exam, your primary responsibility is to demonstrate to your examiner that you know how to drive safely and effectively. You should begin practice in areas with which you are familiar then progress to different areas that will test your driving knowledge and your adaptability to different driving situations. If you completed your training through a commercial school or at home, you can take your test at a local DMV office. Otherwise, you can take your CT Driving Exam at a

secondary drivers training school. You should make sure you get a good nights rest. The vehicle must also be properly insured. If you are enrolled in a driving school you may use the schools vehicle. Pay attention to what your examiner has identified as your weaknesses and work upon improving your driving skills before you take the test again. After this initial six month period, you will be able to drive with members of your immediate family. Additionally, throughout this year, you will not be able to drive between 12 AM and 5 AM. Other documents that are necessary vary depending on what insurance company you choose to use.
